WORKSHOP SPONSOR

This learning experience is presented by International Partnering Associates (IPA). IPA is a cooperative network of individuals, not a mission agency with its own personnel. Each of the globally based partnering associates is part of another mission agency. Through 50 globally based partnering associates, IPA serves over 450 mission entities around the world. Associates have in common a passion to see organizations, ministries, and churches work together to impact the work of Christian mission and ministry.

Currently IPA is represented in the following regions: Southeast Asia Islands, Southeast Asia Mainland, South Asia, Sub-Saharan Africa, Central Asia, South Central Asia, East Asia, North America, and South America. Associates are also involved in regional and trans-regional mission initiatives such as Ethné, Africa AIDS initiative, Refugee Highway, COMIBAM (serving Latin America), Southeast Asia Network, and MANI (Movement of African National Initiatives). Associates have also consulted at World Evangelical Alliance Mission Commission (WEA-MC) and presented at the Lausanne Conference for World Evangelism. Many IP Associates are involved in partnerships where security is a major concern, so publishing specific information is not advisable.

Each associate has years of proven experience in developing and operating actual partnerships among Christian ministries. WORKSHOP APPROACH

The workshop is not your average workshop. It will **NOT** consist of a series of lectures or of theoretical ideas, but will be practical and grounded in actual experiences. IPA facilitators are skilled in providing interactive learning experiences. The workshop will include discussion-based learning, case studies, personal reflection, and enable

you to develop a practical plan of action so that you can confidently begin the process of developing your own partnering approach to ministry. The model of partnering foundational to this training came out of 25 years of forming and developing partnerships among Christian ministries primarily among unreached people groups in Africa, Asia, and the Middle East. Although this is the context in which the workshop was developed, IPA has seen this model successfully used in other contexts beyond impacting unreached people groups.



WORKSHOP LEARNING THEMES

- Working Together: an exploration of the value of a partnering approach to ministry
- God's Passion for Relationships and Partnering: an exploration of the themes of humility, generosity and gratefulness, relationships and prayer and their relationship to God's heart for working together from the Book of Philippians
- Partnering Perspectives: an overview of different approaches to partnering in ministry contexts
- The Partnering Journey: a step by step guide to the phases on the partnering journey, from an awakening to the possibilities of partnering, to preparing yourself and your ministry for partnering, to exploring the possibilities for partnering, to forming a partnering initiative
- Partnering Processes: challenges in changing to a different way of working, and building consensus and trust
- **Planning for Partnering:** developing a detailed plan of how you will personally take the next steps on your partnering journey through to forming the partnering initiative that God has put on your heart
